

**ORDINANCE NO. 18-11**

**BOROUGH OF NORTH PLAINFIELD  
COUNTY OF SOMERSET  
STATE OF NEW JERSEY**

**AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT  
THE BOROUGH CODE OF THE BOROUGH OF NORTH PLAINFIELD,  
CHAPTER VII ENTITLED, "TRAFFIC,"  
SECTION 7-13 ENTITLED,  
"SCHOOL BUS ZONES,"  
MOST NOTABLY,  
SCHEDULE XIX, "SCHOOL BUS ZONES."**

**WHEREAS**, the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey believes that it is in the best interest of the Borough to amend, revise and supplement Section 7-13 of the Borough Code of the Borough of North Plainfield, entitled "School Bus Zones"; and,

**WHEREAS**, the Borough of North Plainfield, County of Somerset, State of New Jersey is authorized by State law to create school bus zones on certain sections of public roads during certain times within the Borough of North Plainfield; and,

**WHEREAS**, the Borough of North Plainfield, County of Somerset, State of New Jersey has determined that the public health, welfare and safety are protected by creating school bus zones along certain streets within the geographic boundaries of the Borough of North Plainfield at certain times.

**NOW, THEREFORE, BE IT ORDAINED** by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that Schedule XIX of Chapter VII, Section 7-13 of the Borough Code of the Borough of North Plainfield, entitled "School Bus Zones", is hereby amended, revised and supplemented by creating school bus zones on the following streets in Schedule XIX as follows:

**SCHOOL BUS ZONES**

In accordance with the provisions of Section 7-13 of the Borough Code, the following described streets or parts of streets are designated as School Bus Zones during the hours 7:00 a.m. to 4:00 p.m. on Mondays through Fridays.

<b>SCHEDULE XIX, SCHOOL BUS ZONES</b>		
<i>Name of Street</i>	<i>Sides</i>	<i>Location</i>
Greenbrook Road	South	Starting at a point 240 feet east of the easterly curb line of Harrington Avenue and extending in an easterly direction a distance of 30 feet.

Grove Street	West	Starting at a point 585 feet south of the southerly curb line of Walnut Street and extending in a southerly direction a distance of 50 feet.
Harrison Avenue	East	Starting at a point 135 feet south of the south curb line of Chestnut Street and extending 50 feet therefrom.
Oneida Avenue	East	Starting at the point of the extended northerly curb line of Hurley Avenue and extending in a northerly direction a distance of 77 feet.
Vine Street	East	Starting at a point 150 feet south of the southerly curb line of Park Place and extending in a southerly direction a distance of 30 feet.
<b><u>Westervelt Avenue</u></b>	<b><u>West</u></b>	<b><u>Starting at a point 40 feet south of the southerly curb line of Jackson Avenue and extending in a southerly direction a distance of 100 feet.</u></b>

**NOW, THEREFORE, BE IT FURTHER ORDAINED** that:

- Proper signage shall be erected or removed after receipt of any approvals required pursuant to state or county regulations and requirements.
- All ordinances or portions of ordinances that are inconsistent with this Ordinance shall be repealed as to their inconsistencies only.
- If any provision or paragraph of this Ordinance shall be held invalid by any court of competent jurisdiction, the same shall not affect the other provisions or paragraphs of this Ordinance, except so far as the provision or paragraph so declared invalid shall be separable from the remainder or any portion thereof.

This Ordinance shall take effect, after final passage, twenty (20) days following action or inaction by the Mayor as provided by law or an override of a mayoral veto by the Council, whichever is applicable and publication in accordance with law, unless a resolution is adopted, pursuant to *N.J.S.A. 40:69A-181(b)*, declaring an emergency and providing that this Ordinance shall take effect at an earlier date.
