WHEREAS, the alleged lowest bidder, Colonial EP, LLC, prices for each bid item were not contained in the bid forms, and was Fifty-Four Percent (54%) lower than the engineer's estimate, it was the opinion of Mott MacDonald, the Borough's consulting engineer supervising on this Project, that the alleged lowest bidder cannot responsibly perform the Contract work for payment of the bid amount; and,

WHEREAS, the alleged lowest bidder, Colonial EP, LLC failed to submit a Certificate of Surety consistent with the bid requirements and the requirements of *N.J.S.A.* 40A:11-22; and,

WHEREAS, Mott MacDonald reviewed all the bid submissions, recommends the award of the bid and contract for the Project to the lowest responsible bidder, Innovative Electrical Contracting Inc., whose main offices are located at 230 Route 206, Suite 2C, Flanders, New Jersey 07836 (hereinafter referred to as the "Contractor"); and,

WHEREAS, Director of Law/Borough Attorney Eric M. Bernstein, Esq., and the offices of Eric M. Bernstein & Associates, LLC, have reviewed the bid submissions and find no material defect with the bid proposal for the Contractor; and,

WHEREAS, the Borough of North Plainfield is desirous of obtaining the services of the Contractor to perform all those services contemplated in the Borough's bid documents and the bid proposal submitted by the Contractor; and,
